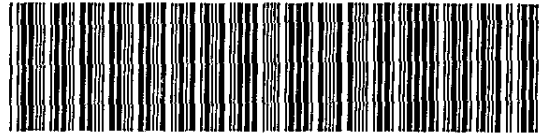



**ARTICLES OF ORGANIZATION  
OF  
HPS OF MARCO, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be HPS of Marco, L.L.C. ("Company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company shall be 20 Fontana Lane, Grosse Pte Shores, MI 48236.

**ARTICLE III -- DURATION**

#### ARTICLE IX -- MANAGEMENT


