ARTICLES OF ORGANIZATION OF UNITED MANAGEMENT, LLC.

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby adopt the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be United Management, LLC. ("Company").

ARTICLE II - ADDRESS

The principal place of business of the Company in Florida and its mailing address is: 1832 Foster Drive, Jacksonville, Florida 32216.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State and shall continue perpetually unless terminated in accordance with the Company's Operating Agreement or by the unanimous written consent of all of the Members.

ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful activity or business for which a limited liability company may be organized under the laws of the State of Florida and the United States. ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
