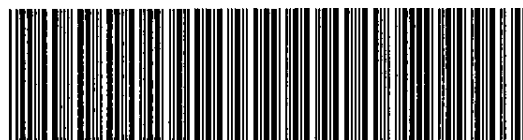

FIFTH


All remaining property and assets have been distributed among its members in accordance with their respective rights and interests; and
