AMENDMENT AND RESTATEMENT OF THE ARTICLES OF ORGANIZATION

OF

AGRICYCLE ALLIANCE, LLC

The Articles of Organization filed March 11, 2004, (FDOS# LO 400001847) are hereby amended and restated under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes ("FRLLCA"), in their entirety and are effective as of February 11, 2024, as follows:

Article I

Name and Adress of the Company

The name of the limited liability company ("Company") is Agricycle Alliance, LLC. The Company's Street and mailing address is 2206 Mahan Drive, Tallahassee, FL 32308.

Article II

Commencement and Duration of the Company

The Company commenced on March 11, 2004, and shall have an indefinite duration.

Article III

Management

Operating Agreement and Regulations

The members of the Company have the power to adopt, alter, amend, or repeal the operating agreement and regulations of the Company containing provisions for the regulation and management of the affairs of the Company.
