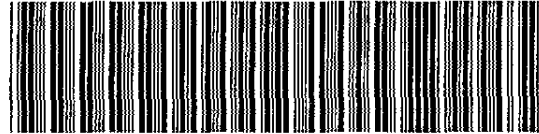

The name of the limited liability company shall be PCB Nauticus, LLC, ("company").






