# ARTICLES OF ORGANIZATION OF P AND D, L.L.C. A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I

Name. The name of the limited liability company shall be P AND D, LLC. ("Company").

#### ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 811 Sutter Loop, Longwood, Florida 32750.

#### ARTICLE III

<u>Duration</u>. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

#### ARTICLE IV

Initial Registered Office and Agent. The street address of the initial registered office of the Company is 111 North Orange Avenue, Suite 1200, Orlando, FL 32801 and the name of the initial registered agent of the Company at that address is THOMAS P. MORAN.

#### ARTICLE V

Management. The Company shall be managed by Peter Moran.

#### ARTICLE VI

Member's Right to Continue Business. The remaining members of the limited liability company shall not have any right(s) to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member, unless expressly consented to in writing by all of the members including the disassociating member. These provisions shall be subject to Article XV of a Franchise Agreement between the Limited Liability Company and Hometown Threads, L.L.C.

#### ARTICLE VII

Operating Agreement and Regulations. Any Operating Agreement and Regulations (as defined in Section § 608.402 of the Act), relating to this Limited Liability Company must be in writing and signed by all of the Members. The Members shall have the power to adopt, alter, or repeal the operating agreement and regulations of the Limited Liability Company containing provisions for the regulation and management of the affairs of the Limited Liability Company. These provisions shall be subject to Article XV of a Franchise Agreement between the Limited Liability Company and Hometown Threads, L.L.C.

#### ARTICLE VIII

<u>Limitation on Agency Authority of Members</u>. Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.
