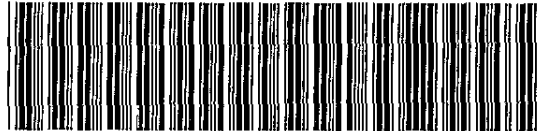

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

- FIRST:** The name and address of this Limited Liability Company is **STALLION HOMES LIMITED LIABILITY COMPANY**, 9408 Roberts Road, Odessa, Florida 33556.
- SECOND:** The Limited Liability Company was filed on March 10, 2004; document number L04000018581.
- THIRD:** The date of the adoption of these Articles of Dissolution is March 16, 2004.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421.
