ARTICLES OF ORGANIZATION OF

FIRST: The date of filing of the Articles of Organization was March 10, 2004 and assigned document number L04000018642.

SECOND: The following amendments to the Articles of Organization were adopted by the limited liability company. The Articles of Organization are being amended in their entirety as follows:

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I — Name:

The name of the Limited Liability Company is: BRANDON PALMS APARTMENTS, LLC

ARTICLE II - Purpose:

The Limited Liability Company is organized solely to purchase, acquire, buy, sell, mortgage, own, trade in, hold, develop, lease, manage, subdivide and otherwise deal in and with the real property and improvements thereon known as Brandon Palms Apartments located at 721-1 N.
