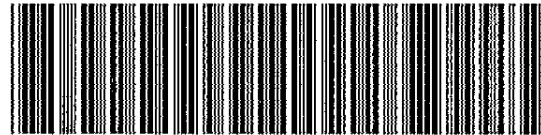

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is **1107 GULF WAY, L.L.C.**

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is **1107 GULF WAY, L.L.C., Kenneth W. Sawyer, Managing Member, PO Box 923, Sparta, New Jersey 07871.**

Article III. Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of St. Petersburg at **696 First Avenue North, Suite 201, St. Petersburg, Florida 33701.** The initial registered agent is **G. 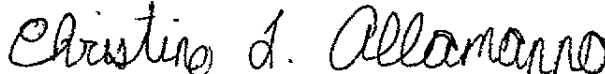

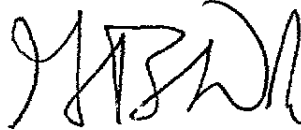
