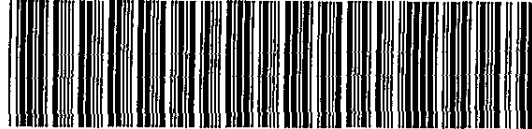

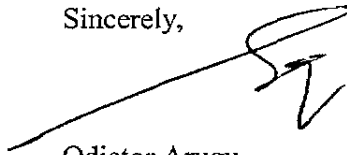

ARTICLE I

Name and Duration

The name of this Limited Liability Company is DOUBLE D CHOPPER LIMITED COMPANY (hereinafter referred to as the "Company"). The duration of this Company is perpetual. The effective date upon which this Company shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office and Mailing Address

### Management By Members

The management of the Company shall be reserved to the Members, unless otherwise provided in the Operating Agreement or other governing instrument. David Gillispie, named as the initial member, shall serve as the initial managing member until the first annual meeting of the Members. The Members may elect, by a majority in interest of the Members, additional managing members of the Company to conduct the business affairs of the Company, all in accordance with the Operating Agreement.

## ARTICLE VII

### Admission of Additional Members

Additional members may be admitted from time to time only upon the consent of a majority in interest of the Members, and the managing members shall determine the amount and nature of contributions by additional members at the time the additional members are admitted.

## ARTICLE VIII

### Operating Agreement

The power to adopt, alter, amend or repeal the Operating Agreement or other governing instrument of the Company is vested in the Members as provided in the Operating Agreement or other governing instrument of the Company.

## ARTICLE IX

### Continuation of Business

The remaining Members of the Company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event, which terminates the continued membership of a Member in the Company. The business of the Company may be continued only on the unanimous consent of the remaining Members.

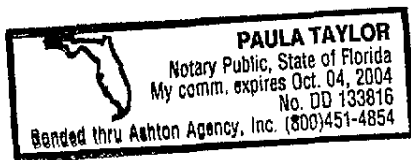
