ARTICLES OF ORGANIZATION OF

We, the undersigned, who intend to form and create a Limited Liability Company, as defined in Section 608 of the Florida Statutes, do hereby state and certify the following:

Article I - Name of limited liability company.

The name of the Limited Liability Company shall be JUAREZ BROTHERS, L.L.C.

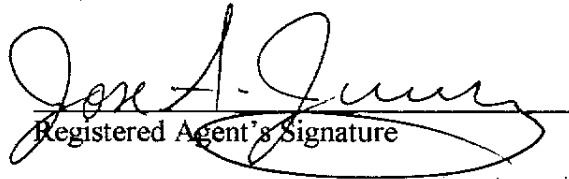
Article II - Location of company office and mailing address

Article V – Purpose and duration of company.

The purpose for which the company is formed is to engage in any lawful acts or activities for which limited liability companies may be formed under Section 608 of the Florida Statutes or any successor statute. The company shall have a perpetual existence.

Article VI - Restrictions on Member's Transferability

A new member may be admitted into the company only if all the other members approve of such admission and said new member executes such instruments as the other members determine are necessary or desirable to effect such admission and to confirm the agreement of the person or entity being admitted to be bound by all of the covenants, terms and conditions of the operating agreement then in effect. The company shall have no obligation to purchase some or all of the company's interest held by a member attempting to withdraw. No member may transfer, assign, sell, give, pledge, hypothecate or otherwise encumber his or her interest in the company without the prior written consent of all members, and any attempt to do any of the foregoing without such prior written consent shall be null and void and of no effect. Upon the death of a member, the estate of the deceased member shall be entitled to receive the deceased member's proportionate share of the cash flow of the company for that part of the company's fiscal year that elapsed prior to the deceased member's death and the company shall purchase the deceased member's interest for the price determined through those procedures set forth in the operating agreement in effect at such time.

Article VII - Continuation upon Event Constituting Termination

Upon the death, retirement or resignation of a member, provided that at least one member remains, the company shall continue operations unless a majority of the remaining members present and eligible to vote at a special meeting vote to terminate the business of the company. In the event of a dissolution of the company, the business affairs of the company shall continue to be governed by the terms of the operating agreement during the winding up of the company's business and affairs.

Article VIII – Treatment as a Partnership for IRS Purposes

Initially, and until otherwise designated by the vote of a majority of members of the company, the company elects to be treated as a partnership for federal income tax purposes.

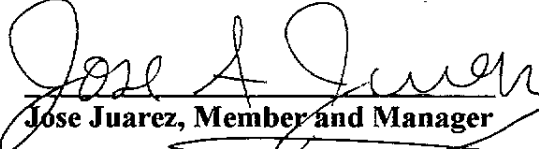
Article IX - Amendments to the Articles

Such amendment shall be promptly filed with the Secretary of the State of Florida in accordance with the statutory requirements for a Limited Liability Company.
