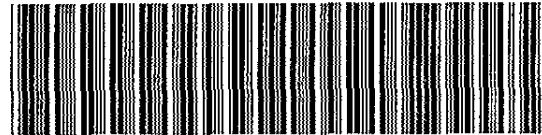

ARTICLE I — Name:

The name of the Limited Liability Company is **FLORIDA DEVELOPMENT, LLC**.

ARTICLE II — Address:

ARTICLE III — Purpose:

The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the State of Florida.

ARTICLE IV — Registered Agent & Registered Office :


ARTICLE VI — Management:
