

**ARTICLES OF ORGANIZATION OF
ORANGE LAKE PARTNERS, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "ORANGE LAKE PARTNERS, LLC."

ARTICLE II - Address

The mailing address is Post Office Box 1479, Ocala, Florida, 34478, and the street address of the principal office of the Company is 1701 S.E. Fort King Street, Ocala, Florida 34470.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

**ARTICLE IV - DESIGNATION OF REGISTERED AGENT
INITIAL ADDRESS OF REGISTERED OFFICE**

The Company is to be managed by the members.
