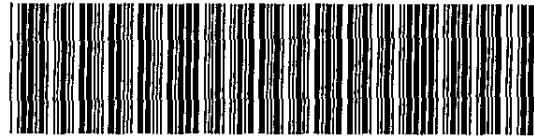



**ARTICLE II - ADDRESS**



The Company shall be dissolved upon the happening of any of the following:


(1) Upon written agreement of two-thirds of the membership.




