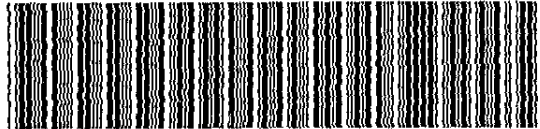

The Limited Liability Company will initially have one member, ARTHUR STOVER. The Limited Liability Company is to be managed by a manager and the name and address of the manager is:



**Members Rights to Continue Business**


