ARTICLES OF ORGANIZATON

EFFECTIVE DATE

- 1. Name. The name of this limited liability company is FRED N. TEUMAC CONSULTING, LLC (the "Company"), and it shall be formed as a limited liability company under the Florida Limited Liability Company Act.
