ARTICLES OF ORGANIZATION FOR A FLORIDA LIMITED

ARTICLE I - Name:

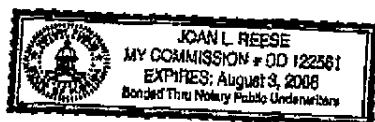
