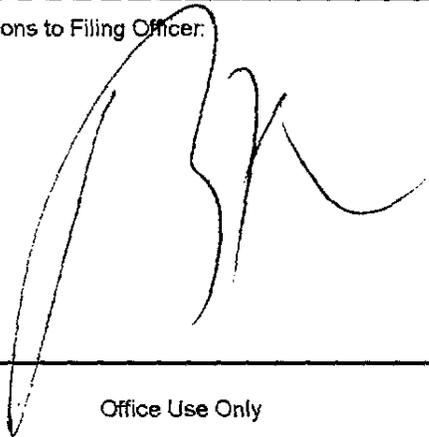

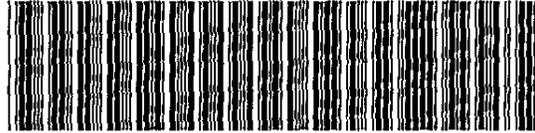

Operating Agreement

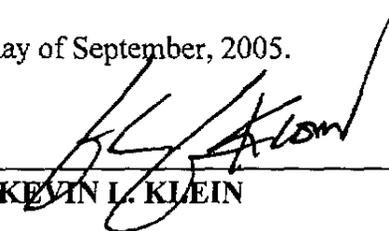

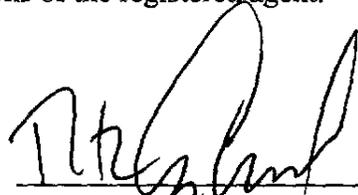
