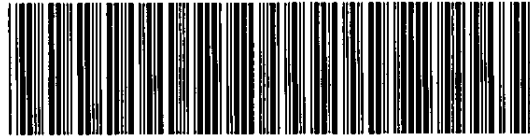

This amendment is submitted to amend the following:

- A. The name is amended to KLEIN RANCH, LLC.
- B. The aggregate number of membership units the limited liability company is authorized to issue is 10,000 units. Such membership units shall be in two classes and shall have a par value of One (\$1.00) Dollar per share, Class A membership units and Class B membership units. 9,500 units shall be Class A membership units and 500 shall be Class B membership units. The owners/holders of Class A membership units shall have exclusive voting power and rights on all matters, including, but not limited to, all matters identified in Florida Statutes. The owners/holders of Class B membership units shall have no voting power rights on any matter.
