ARTICLES OF ORGANIZATION

Kenneth Worcester's Handyman Service, LLC

A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)

1. Name. The name of the limited liability company is Kenneth Worcester's Handyman Service, LLC.
2. Purpose. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. Address of Principal Office. The address of the registered office of the limited liability company is 14 Church Avenue, Englewood, Fl 34223.
4. Term. Term of this LLC shall be perpetual.
