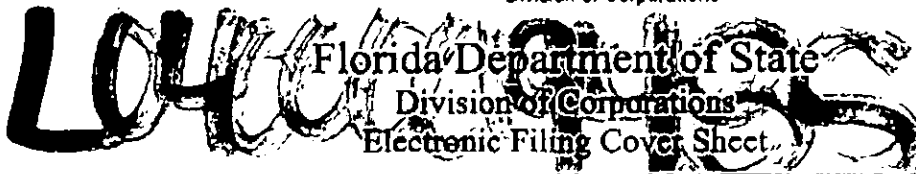

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
LAKE GRAY FAMILY PHYSICIANS, L.L.C.**

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Lake Gray Family Physicians, L.L.C., originally filed on March 3, 2004, are amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is Lake Gray Family Physicians, L.L.C. (the "Company").

ARTICLE II - ADDRESS

The street and mailing address of the Company's principal office are:

ARTICLE III - PURPOSE

The Company is organized for the purpose of performing all lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - DURATION AND EXISTENCE; EFFECTIVE DATE

The Company will exist perpetually. These Amended and Restated Articles of Organization shall be effective as of January 1, 2018, unless the filing of these Amended and Restated Articles of Organization occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing of these Amended and Restated Articles of Organization with the Secretary of State of the State of Florida.

ARTICLE V - REGISTERED OFFICE AND AGENT

The Company (i) designates 6142 Collins Road, Jacksonville, Florida 32244 as the street address of the Company's registered office, and (ii) names Robert A. James as the Company's registered agent at that address.

ARTICLE VI - MANAGEMENT AND AUTHORITY

The Company shall be a manager-managed company. Pursuant to Section 605.04074, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a

member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

ARTICLE VII - INDEMNIFICATION

The Company shall indemnify any person who is or was a party to any proceeding by reason of the fact that such person is or was a manager, member or officer of the Company or its subsidiaries, to the fullest extent not prohibited by law, for actions taken in the capacity of such person as a manager, member or officer of the Company or its subsidiaries. To the fullest extent not prohibited by law, the Company shall advance reasonable indemnification expenses, (including attorneys' fees and costs) for actions taken in the capacity of such person as a manager, member or officer within twenty (20) days after receipt by the Company of (i) a written statement requesting such advance, (ii) evidence of the expenses incurred, and (iii) a written statement by or on behalf of such person agreeing to repay the advanced expenses if it is ultimately determined that such person is not entitled to be indemnified against such expenses.

The undersigned, for the purpose of amending and restating the Company's Articles of Organization under the laws of the State of Florida, has executed these Amended and Restated Articles of Organization.
