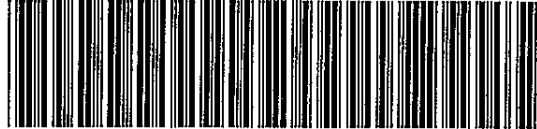



ARTICLES OF ORGANIZATION
OF
PAPP PROPERTIES, LC

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE 1 – NAME

The name of the limited liability company shall be PAPP PROPERTIES, LC (The “Company”).

ARTICLE 11 – DURATION

The Company shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE 111 – PURPOSE

Management of this limited liability company is reserved to its member, whose name and address is as follows:



The Company shall have the power to amend or supplement these Articles of Organization when approved by the Manager.


