**ARTICLES OF ORGANIZATION
OF
WHARFSIDE INVESTORS II, LLC**

In accordance with the provisions of the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, (the "Act") the undersigned, sole organizer of a Florida limited liability company, and an authorized representative of a Member of the Company hereby files these Articles of Organization:

ARTICLE I -- NAME

The name of the limited liability company is Wharfside Investors II, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company in the State of Florida is, 300A Wharfside Way, Duval County, Florida, 32207.

ARTICLE III -- REGISTERED AGENT & OFFICE
