**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF  
GREAT OAKS LAND DEVELOPMENT, L.L.C.**

**FIRST:** The Articles of Organization were filed on March 3, 2004, and assigned document number L05000019788.


**SECOND:** The following Amendment to Articles of Organization were adopted by Great Oaks Land Development, L.L.C.:

1. Great Oaks Land Development, L.L.C. shall have the power and authority to own and convey real and personal property;
2. Great Oaks Land Development, L.L.C. shall have the power to operate and maintain the Surface Water Management System facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, wetlands, and any associated buffer areas and wet land mitigation areas;
3. Great Oaks Land Development, L.L.C. shall have the power and authority to establish rules and regulations;
4. Great Oaks Land Development, L.L.C. shall have the power and authority to assess members and enforce assessments;
5. Great Oaks Land Development, L.L.C. shall have the power and authority to sue and be sued;
6. Great Oaks Land Development, L.L.C. shall have the power and authority to contract for services to provide for the operation and maintenance of the surface water management facilities if the association ~~contemplates employing a maintenance company;~~

7. Great Oaks Land Development, L.L.C. shall have the power and authority to require all lot owners, parcel owners, or unit owners to be members of the association;
8. Great Oaks Land Development, L.L.C. shall exist in perpetuity; however, if this organization is dissolved, the control or right of access to the property containing surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and, that if not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the association.
