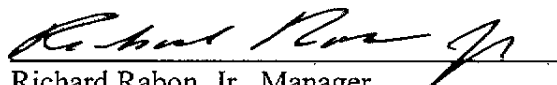
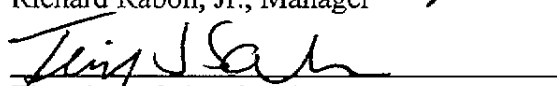
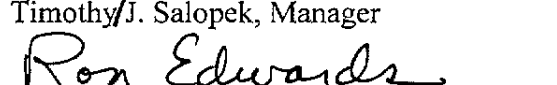
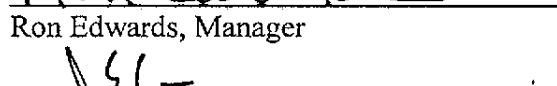
#### ARTICLE VI - Admission of Additional Members
