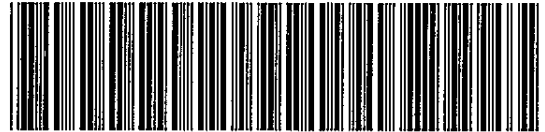

FIFTH: All remaining property and assets belonging to the Company have been distributed among its members in accordance with their respective rights and interest in the Company.


SIXTH: There are no suits pending against the Company in any court.
