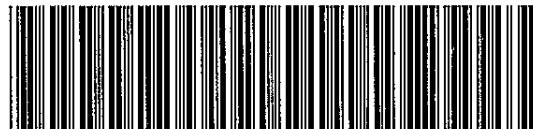

**ARTICLE 3**

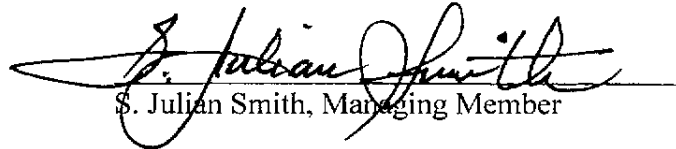
**PRINCIPAL OFFICE AND REGISTERED AGENT**
