ARTICLE I

Name

Name and Address of Registered Agent



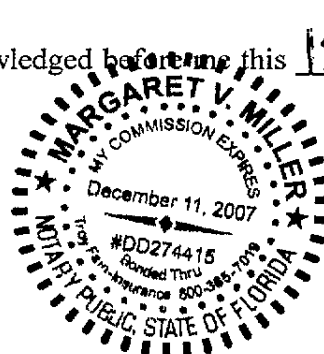
