

**ARTICLES OF ORGANIZATION
OF

FIRST: The name of this limited liability company shall be Frontier Medical Group, L.L.C. (the "Limited Liability Company").

SECOND: The period of duration for the Limited Liability Company shall be perpetual unless sooner dissolved in accordance with the laws of the State of Florida.

THIRD: The mailing and street address of the principal office of the Limited Liability Company shall be 1725 Mayacoo Lakes Boulevard, West Palm Beach, Florida, 33411.


