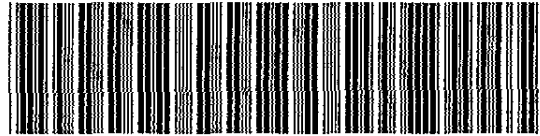




ARTICLE VI - INDEMNIFICATION
