PLAN OF MERGER

THIS PLAN OF MERGER of TANGLEWOOD ASSOCIATES OF LAKE COUNTY LIMITED PARTNERSHIP, a Florida limited partnership, and SM-EUSTIS, LLC, a Florida limited liability company, pursuant to <u>Chapter 608.438 Of The Florida Statutes</u>, is adopted as follows:

- A. TANGLEWOOD ASSOCIATES OF LAKE COUNTY LIMITED PARTNERSHIP, a Florida limited partnership, shall be merged with and into SM-EUSTIS, LLC, a Florida limited liability company, to exist and be governed by the laws of the State of Florida.
- B. The name of the surviving limited liability or business entity shaft be SMEUSTIS, LLC, a Florida limited liability company.
- C. When this Agreement becomes effective the existence of TANGLEWOOD ASSOCIATES OF LAKE COUNTY LIMITED PARTNERSHIP, shall cease and the surviving entity, SM-EUSTIS, LLC, a Florida limited liability company, shall succeed, without other transfer, to all of the rights and property of TANGLEWOOD ASSOCIATES OF LAKE COUNTY LIMITED PARTNERSHIP and shall be subject to all of the debts and liabilities of said joint venture in the same manner as if the surviving limited liability company had itself incurred the same. All rights of creditors and all liens on the property of each entity shall be preserved unimpaired, limited to the lien to the property effected by the liens immediately prior to the merger.
- D. The surviving entity, SM-EUSTIS, LLC, will carry on business with the assets of said limited partnership as well as the assets of its own.
- E. The general and limited partners of TANGLEWOOD ASSOCIATES OF LAKE COUNTY LIMITED PARTNERSHIP, a Florida limited partnership, shall surrender all of their ownership interests therein in the manner hereinafter set forth.

- F. In exchange for the contribution of their respective existing partnership interests, each of such partners shall receive units of ownership in the limited liability company in direct proportion to the ownership interest which each had held in the joint venture and in such a manner so that each shall have and hold the same ownership percentage interest of the total ownership interest in the limited liability company as they had held in the joint venture.
- G. The Articles of Organization of the limited liability company, which is the survivor of this merger, shall continue in full force as the Articles of Organization of the survivor until altered, amended or repealed hereafter.
- H. Management of the surviving limited liability company is vested in two Managers, whose name and business address is as follows:
