Enclosed is a copy of the letter issued by your office requiring our client, Bassett Family Investments, LLC, to obtain an Employer Identification Number. This had not been done because the entity is inactive and because it is a single member LLC not required to file a return separate from its owner. We have entered the EIN on a copy of the Florida Corporation Annual Report previously submitted.

Many taxpayers have established single-member LLCs. Virtually all of them will never file a Federal return, and are not required to do so by IRS. All income and expenses are reported directly on the owner's tax return. Therefore, there is no need for an Employer Identification Number as far as IRS is concerned.
