**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
LANCOR, L.L.C.**

The undersigned, being all of the members of LANCOR, L.L.C., hereby adopt the following Amended and Restated Articles of Organization pursuant to §605.0202 of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), for the purpose of amending and restating the Articles of Organization of the company filed with the Florida Department of State on March 17, 2004:

ARTICLE I - NAME


ARTICLE X - TERMINATION OF A MEMBERSHIP INTEREST


