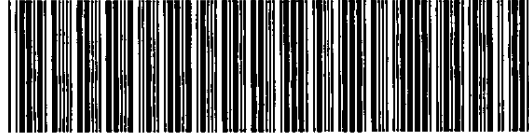

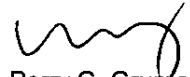

As chief restructuring officer, the agent shall have full and complete power to act on behalf of and in the name, place, and stead of the company in connection with any case, estate or proceeding initiated, filed and/or commenced by or against the company under title 11 of the United States Code, including, without limitation, the filing of any proceeding under Chapter 11 and/or Chapter 7 thereunder and/or in connection with any reorganization, debt modification, debt negotiation, insolvency proceeding, and/or liquidation action or proceeding brought by and/or against the company. Without limiting the generality of the foregoing, the agent is authorized to:

1. Execute any petition, declaration, schedule, statement of financial affairs, plan of reorganization, or any other document in any way related or pertaining to any bankruptcy, insolvency, liquidation, and/or reorganization case or proceeding brought by or against the company, and/or related to the financial condition, income, expenses, and/or debts of the company, and/or execute any amendment thereto.
2. Give testimony (under oath or otherwise) and/or represent the company in any court or administrative hearing, deposition, reorganization or liquidation proceeding, 341 meeting of creditors, and/or any formal and/or informal meeting with the office of the United States Trustee or its agents or representatives.
3. Execute any monthly operating report required under Title 11 of the United States Code or any other law and/or required by the office of the United States Trustee.
4. Provide any books and/or records and/or any financial information on behalf of the company to the United States Trustee, any creditor of the company, or any other person or party.
5. Pay, negotiate and/or compromise any debt or obligation of the company to any creditor or third-party.
6. Make any other payment on behalf of the company which is necessary and/or advisable in the performance of the agent's duty hereunder, within the reasonable discretion of the agent.
