**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, Laramie Properties, LLC adopts these Articles of Amendment:

**FIRST:** The name of the limited liability company is Laramie Properties, LLC (the "Company") and the assigned document number is L04000020935.

**SECOND:** The Articles of Organization were filed on March 17, 2004.

**THIRD:** Article VI of the Company's Articles of Organization is amended in its entirety to read as follows:

**Article VI
