



ARTICLES OF ORGANIZATION
OF
CANGRO, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be CANGRO, LLC ("Company").

ARTICLE VII - ADMISSION OF NEW MEMBERS




