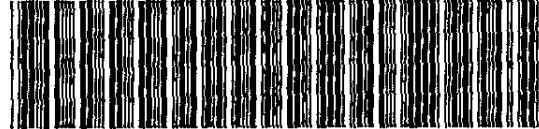



ARTICLE I — Name
