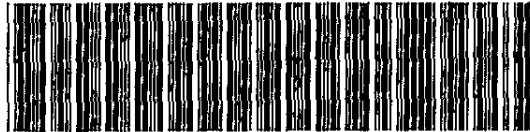

**ARTICLE I - Name**

The name of the limited liability company (hereinafter referred to as the "Company") is "CAS Enterprises Construction, LLC".

**ARTICLE II - Address**

**ARTICLE III - Duration**

The period of duration for the Company shall be perpetual.
