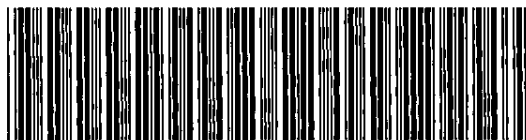

TO  
ARTICLES OF ORGANIZATION

Tallahassee Housing Professionals, LLC

(Present Name)  
(A Florida Limited Liability Company)

**FIRST:** The Articles of Organization were filed on March 22, 2004 and assigned document number L04000021765.

**SECOND:** This amendment is submitted to amend the following:

NEW ARTICLE :Tallahassee Housing Professionals, LLC ("THP") is organized exclusively for exempt purposes under 501(c)(3) of Internal Revenue Code, and may not carry on activities not permitted to be carried on by organization described in Section 501(c)(3). THP is operated exclusively to further the charitable purposes of its member, Tallahassee Housing Authority ("THA"), which is a political subdivision of the State of Florida. THP is prohibited from making a direct or indirect transfer of any membership interest to a transferee not authorized in Section 501(c)(3). Upon dissolution of THP, the assets devoted to its charitable purposes will be donated to THA. Any amendment to THP's Articles of Organization must be consistent with Section 501(c)(3). THP may not merge or convert into a for profit entity. No assets of THP may be distributed to a member that ceases to qualify pursuant to Section 501(c)(3). If a member cease to qualify pursuant to Section 501(c)(3), THP will be dissolved as provided herein. THA as the sole member, will enforce its rights in THP and take any legal or equitable actions to protect its interest in THP. THP represents that the provisions in these Articles of Organization are consistent with applicable Florida Laws and are enforceable at law and in equity.
