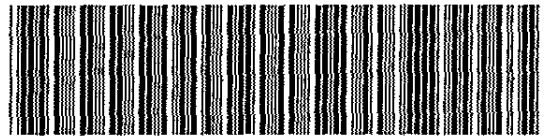

THE UNDERSIGNED, desiring to form a Limited Liability Company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Article of Organization for such company:

**ARTICLE I - NAME**

**ARTICLE II - DURATION/CONTINUATION**
