AND CHANGING ITS NAME TO QUINTANA CHUPP & ASSOCIATES, LLC**


Pursuant to the provisions of the Florida Limited Liability Company Act, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:


1. The Articles of Organization for CONSIGNMENT TOO, LLC were filed on March 22, 2004.
