**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
Name**

The name of the limited liability company ("Company") is PRECISE CONSULTING, LLC.

**ARTICLE II
Address**

The mailing and street address of the Company's principal office is P.O. Box 864, Anna Maria, Florida 34216.

**ARTICLE III
Duration**

The period of duration for the Company is perpetual.

**ARTICLE IV
Registered Agent and Office**

The Manager shall have the authority to exercise all powers of the Company and to do all things necessary to carry out its business and affairs described in Florida Statutes Section 608.404, as from time to time amended, including, but not limited to, the power to acquire, mortgage, encumber, sell, lease, convey, and transfer the Company's real and personal property.


**CERTIFICATE OF DESIGNATION OF
