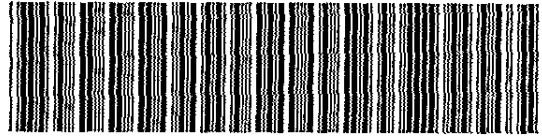

**ARTICLES OF ORGANIZATION
FOR
FLORIDA LIMITED LIABILITY COMPANY**

**ARTICLE I
NAME**

The name of the limited liability company shall be BEA Ridge Construction Cleaning LLC.

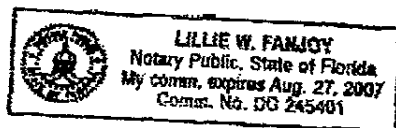
