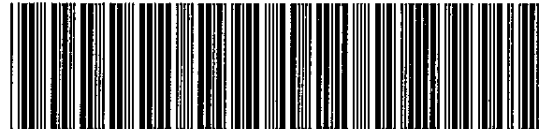

The undersigned, for the purpose of forming a limited liability company under Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **GET-ME-A-MORTGAGE !, LLC**, ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1712 Wind ft Road, Orlando, Florida 32809 and the mailing address shall be 424 East Central d., Ste. 123, Orlando, Florida 32801.

**ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of Secretary of State, State of Florida.




