**ARTICLES OF ORGANIZATION
OF
MEDICAL ARTS AT VILLAGE SQUARE, L.L.C.**

The undersigned for the purpose of creating a limited liability company under the Florida Limited Liability Company Act (the "Act"), Chapter 608, Florida Statutes, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company is **MEDICAL ARTS AT VILLAGE SQUARE, L.L.C.** (the "Company").

ARTICLE II - DURATION

This Company shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

The mailing address and street address of the initial principal office of the Company is **1166 West Newport Center Drive, Deerfield Beach, FL 33442**. The initial registered agent for the Company at that address is **James Young**.

ARTICLE IV - ADDITIONAL MEMBERS

No person may be admitted as a Member unless each existing Member consents in writing to the admission of the additional Member.

ARTICLE V - RIGHT TO CONTINUE BUSINESS

The remaining Members Company may continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member of the Company.

ARTICLE VI - MANAGER MANAGEMENT

The business and affairs of the Company shall be managed under the direction of Manage who may also be a member and in such instance shall be referred to as the Managing Member, who may exercise all powers of the Company and perform or authorize the performance of all lawful acts which are not by the Act or the Regulations adopted by the Company directed or required to be exercised or performed by the Members. This Company shall have at least one Manager initially with the exact number of Managing members to be specified by the Members from time to time unless the Members shall by a majority vote, determine that the Company be managed solely by the Manager. The name and address of the initial Member and Manager is James Young, 1166 West Newport Center Drive, Deerfield Beach, Florida 33442.

ARTICLE VII - INDEMNIFICATION

The Company shall indemnify and hold harmless any Manager or any former Managing Member, to the fullest extent permitted by law either now existing or hereafter enacted from and against any and all claims and demands whatsoever.


