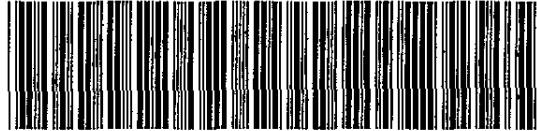

**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF**

**BEST INVEST, LLC**

This limited liability company shall have all of the powers enumerated in the Limited Liability Act.

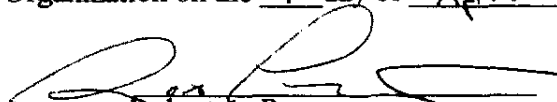
**ARTICLE VIII**
