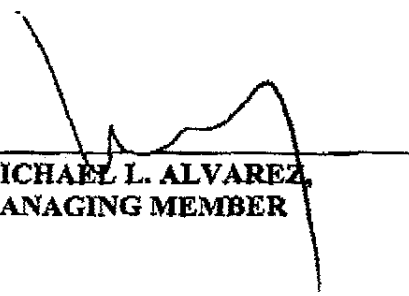
The Articles of Organization are hereby amended to add the following:
