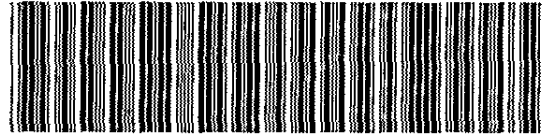

**ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - NAME

The name of the Limited Liability Company is Vero-Pittsburgh Partners, LLC.

These Articles of Organization shall be effective upon the date of filing.


