**ARTICLE I - Name:**

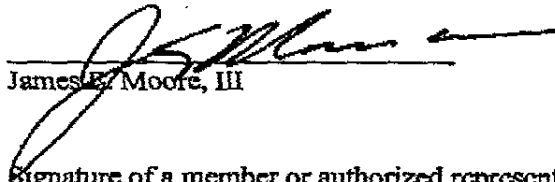
