**ARTICLE I — NAME:**


### ACCEPTANCE OF REGISTERED AGENT

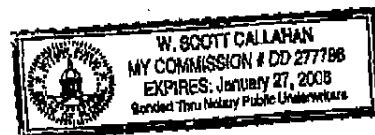
